RESOLUTION # 19 – 04-03

A RESOLUTION TO APPROVE THE EXPENDITURE OF CAPX2020 FUNDS TO INSTALL PRIVATE DRIVE AND TOWN ROAD SIGNS AS REQUIRED BY THE 'BUFFALO COUNTY UNIFORM ADDRESSING ORDINANCE'.

WHEREAS, Buffalo County has adopted a revised Uniform Addressing Ordinance which corrected irregularities and shortfalls in the County's addressing system; and

WHEREAS, one of the larger irregularities pertains to addressing properties on private driveways with multiple addresses/principal structures; and

WHEREAS, an additional substantial irregularity is Town roads within the County having identical names which is misleading to emergency responders and potentially perilous to Buffalo County residents; and

WHEREAS, The Zoning Committee reviewed uniform addressing irregularities and ordinance solutions on October 16, Nov. 6, Dec. 4, 2018, and Jan. 7, March 5, 2019 ; and

WHEREAS, The expenditure of CAPX funds will be limited to the initial cost of installation of those private drive and town road signs that will bring those properties, locations and roads into compliance with the Uniform Addressing Ordinance; and


WHEREAS, the expenditure of CAPX funds will allow for the timely naming and signing of those private drives and Town roads which must be accomplished prior to the installation of new address signs scheduled to begin spring of 2019 ; and

NOW, THEREFORE BE IT ORDAINED, that the Buffalo County Board of Supervisors hereby approves the expenditure of CAPX funds to name and sign those locations in Buffalo County that are incongruous with the Uniform Addressing Ordinance and pose an encumbrance to emergency services and emergency responder locating efforts:






