A RESOLUTION TO INCREASE LAW ENFORCEMENT PROCESS SERVICE FEES FOR THE CHILD SUPPORT PROGRAM

WHEREAS, the Buffalo County Sheriff's Department charges fees for numerous services provided to the public at the public's request, and;

WHEREAS, pursuant to Wisconsin Statute 814.705(1)(a), a county board may establish a higher rate of fees collected by the sheriff, and;


WHEREAS, in accordance with Wisconsin Statute 814.705(1)(a), the Buffalo County Board has approved Resolution #15-08-03 in regard to Buffalo County Sheriff Department's service fee schedule effective August 24, 2015, and;

WHEREAS, the Buffalo County Sheriff's Department charges the Buffalo County Child Support office for process service fees; however, does not receive payment until the Buffalo County Child Support Agency collects the fees from the participant. In the future the Buffalo County Sheriff's Department may elect to receive payment at the time of billing rather than after the participant has paid the fees, and;



WHEREAS, the Buffalo County Sheriff's department charges fees for numerous services provided to the public at the public's request; and



ADDENDUM
BUFFALO COUNTY SHERIFF'S OFFICE FEE SCHEDULE

The Buffalo County Sheriff's Office shall charge of the service of Civil Process, legal notices and other actions as prohibited by law. There are exceptions, including, but not limited to:

- **INDIGENCY:** An indigent person must have an Order of Waiver of Fees from the court of jurisdiction.
- **TEMPORARY RESTRAINING ORDERS (TRO's) and INJUNCTIONS:** May be exempt from fees, depending upon the basis of the court order.

The Buffalo County Board, pursuant to Wis. Stat. §814.705(a) and approved County Resolution establishes fees as follows:

(If self-addressed envelope is not included to return documents, postage will be charged in addition to service fees)

Paper Service - \$75.00 per service (includes up to 3 attempts and mileage)

Paper Service, Additional Defendant at same address - \$35.00

Paper Service, Additional Defendant at different address - \$75.00 per service (includes up to 3 attempts and mileage)

Paper Service (Each Attempt OVER 3 attempts) - \$30.00

Writs of Assistance, Restitution & Replevin - \$75.00 (includes mileage)

Evictions - \$75.00 (Includes mileage)

Sheriff's Sales - \$75.00 for posting, \$75.00 for held sale (No return of fees upon cancellation)

**Paper copies - Accident/Incident Reports - \$3.00, .25¢ after 12th page + postage;
Large records requests-.25¢ per page + postage**

CDs-\$10.00 DVDs-\$25.00

Fingerprinting - \$10.00

Faxing Copies - \$1.00 for first page, .25¢ additional pages (local/non-local calls)

Drug Tests-NON ORDERED - \$15.00

Escorts or Standby of Deputy - \$50.00 per squad, + over-time (including benefits) per hour at current pay rate of deputy (minimum of 2-hour)
