A RESOLUTION TO AMEND NON-METALLIC MINING RECLAMATION ANNUAL FEES

WHEREAS, the Buffalo County Land Conservation and Resource Management Department administers the non-metallic mining reclamation program within Buffalo County as required by Chapter NR 135, Wis. Stats.; and

WHEREAS, Annual fees collected are based on the un-reclaimed area of disturbance and reflects the reasonable and actual costs for administering the non-metallic mining reclamation program, including reclamation plan review, inspection, reporting, and compliance; and

WHEREAS, the Buffalo County Board of Supervisors has previously established a nonmetallic mining reclamation annual fee for un-reclaimed acres; and

WHEREAS, the Land Conservation and Resource Management Committee has reviewed the reclamation program requirements and has suggested revisions to the annual fees to reflect reasonable and actual program administration costs; and

NOW, THEREFORE BE IT RESOLVED that the Buffalo County Board of Supervisors hereby approves the following revised annual non-metallic mining reclamation fee schedule.
