**Sheriff Schmidtknecht:** Reported there was one fatal motorcycle accident for the month of June, rider missed a curve and was not wearing a helmet. There was discussion of the ATV/UTV ordinance; the sheriff's office will be able to offer enforcement up to a certain point.

**Bruce Fuerbringer:** Reported that he's been busy collecting and distributing PPE and that Covid-19 is still the primary issue for the county, in all aspects.

**Bob Platteter:** Reported that the first round of mowing has gone through, second pass will be done later. County Rd. P is now paved. County Rd. TT is having culverts replaced from the north end to the other end near STH 37. County Rd. E project is still being reviewed for alternatives to the dug way, however, the work has to be done this year.

**Dan Kontos:** Reported that as of July 15<sup>th</sup>, the state is down in crashes. They are still working on adding ATV/UTV crashes overlay to Community Maps.

**Rick Tumaniec:** Reported that STH 121, STH 88-STH 93 should be done by the end of October. Flagging operations will be covered.

Jerilyn Baures: Reported that Flyway Trail is open in Buffalo City, it does need to settle.

**Josh Reed:** Reported that due to Covid, we are to expect more traffic around schools as parents are allowed to "bus" their children to school versus having them ride the school bus. Bus routes are being figured out, as well as the seat spacing. County Rd. E's weed control is an issue for school buses. Maybe weeds can be mowed or controlled chemically.

**Dean Haigh:** Reported that Covid-19 appears to have affected the number of crashes. In the beginning, crashes were at a low but now numbers are steadily increasing.

Sheriff Schmidtknecht made a motion to approve previous minutes, second by Mr. Tumaniec. Motion carried.

**Sheriff Schmidtknecht:** Reported that on February 18<sup>th</sup> there will be a 10<sup>th</sup> grade presentation at the Alma High School, which includes the simulator. Three vehicle accident in November on the Wabasha Dike Rd, near the first wayside. All three vehicles went into the water. Two vehicles went in on the north side, where the water runs about 17' deep and one vehicle went in on the south side. DOT will look into whether or not guardrails or some type of cable rail could be installed. No parties were physically injured.

**Bruce Fuerbringer:** Discussed regional response with the Menomonie teams, it's still up in the air. The 2003 command trailer was sold on online auction for \$8,650. He plans to use the funds towards the purchase of courthouse AEDs.

**Bob Platteter:** Discussed the stretch of Hwy 88 where only the spread of salt brine, not rock salt was done. They need to commit a stretch of highway in order to be approved for a purchase of a new brine maker, it's a 10 year sign-on.

County Rd. G out of Fountain City bridge replacement is happening now. There is a concern for safety.

**Dan Kontos:** Addressed the fatalities on Hwy 95 and Hwy 25 for 2019. Legislatives have been updated in 2020, regarding OWI-THC laws can be accessed by the public. April is National Distracted Driving month. Also, April 6<sup>th</sup>-10<sup>th</sup> focuses on work zone awareness.

**Rick Tumaniec:** The MN DOT is managing the work being down near Wabasha. There are only three carryover jobs to be done in 2020. He will provide the committee the 6-year upcoming program for work.

**Jerilyn Baures:** Expressed her concerns for the Wabasha Dike road situation in relation to the amount of crashes.

Josh Reed: Excused

**Sgt. Dean Haigh:** Reported 7 fatalities for the year, so far.

Norita Willadsen: Excused
