## BUFFALO COUNTY COMMITTEE MEETING MINUTES

**Committee/Board:**

Highway Committee

**Date of Meeting:**

Tuesday, November 10, 2020

Mr. Don Hillert called the meeting to order at 8:03 a.m.

**Committee Members Present:** Mr. David Danzinger, Mr. Dwight Ruff, Mr. John Sendelbach and Mr. Don Hillert. Mr. Max Weiss arrived at 8:24 a.m.

**Others present for all or parts of meeting:** Ms. Sonya Hansen, Mr. John DeWitt, Mr. Dennis Bork, Mr. Larry Grisen and Mr. Kelly Johnston.

**Approval of Minutes:** A motion was made by Mr. Danzinger seconded by Mr. Ruff to approve the minutes of October 13<sup>th</sup> with the correction that the Zoning project with the State DOT did not reduce the weed control funds so that a second mowing could not be completed. Mr. Danzinger stated that this project was approved by the State DOT and it was agreed upon that no recoupment would be requested from the landowner. He stated that the funding had come from the weed control funds but that it did not reduce Buffalo County's allocation for the second moving as stated in the minutes. Motion carried.

**Public Comments Regarding Posted Agenda Items:** There were no public comments.

**Read and Approve Vouchers:** A motion was made by Mr. Danzinger seconded by Mr. Ruff to approve the vouchers as presented. Motion Carried.

**Consideration/Action – Staffing:** A motion was made by Mr. Hillert seconded by Mr. Ruff to enter into closed session to conduct Highway Commissioner interviews. Roll Call – Mr. Danzinger – yes, Mr. Weiss – yes, Mr. Ruff – yes, Mr. Sendelbach – yes and Mr. Hillert – yes. Motion Carried.

A motion was made by Mr. Hillert seconded by Mr. Danzinger to return to open session. A roll call vote was taken Mr. Weiss – yes, Mr. Ruff – yes, Mr. Hillert – yes, Mr. Danzinger – yes and Mr. Sendelbach – yes. Motion Carried.

**Consideration/Action – Roads & Bridges:**

**Winter Maintenance Services “Draft” Policy:** A motion was made by Mr. Weiss seconded by Mr. Ruff to approve the Winter Maintenance Services Policy with the change to the last paragraph to reflect the work will be performed by the DEPARTMENT per the agreed upon policies of the COUNTY. Motion Carried.

**CTH “F” UPDATE:** Mr. DeWitt reported that the engineer had obtained the permit from the DNR and was working through some details with the Corp of Engineers. He stated that they intend to rent equipment from American Express Excavator with an extended arm to complete this project as the County does not own this type of equipment.

**CTH “E” WALL UPDATE:** Mr. DeWitt reported that the walls have been removed and the bank tiered. The engineer recommended installing a 4-foot wall next Spring. They have placed a heavy dose of winter wheat on the banks. He presented the option of renting Jersey barriers or waiting to purchase the wall next spring. A motion was made by Mr. Ruff seconded by Mr. Weiss to place signs that warn

the public to watch for falling rocks and to not rent barriers for the winter and to review the project in early Spring. Motion Carried.

**PAVING STATUS:** Mr. DeWitt stated that the paving projects have been completed.

**COVID-19 – NEIGHBORING COUNTY MUTUAL AID:** Mr. DeWitt reported that he has been discussing with Pepin County and Trempealeau County about coverage for snow plowing in the event Buffalo County does not have staff to cover all the snowplow routes. They are working on agreements and policy. He stated he had also contacted Wabasha County and that they would not have the capacity to assist. He did reach out to Winona County but had not received any response from them.

**CONSIDERATION/ACTION – DEPARTMENT OPERATING HOURS:** A motion was made by Mr. Sendelbach seconded by Mr. Danzinger to table this matter until the new Highway Commissioner is appointed. Motion Carried.

**CONSIDERATION/DISCUSSION/ACTION – ATV/UTV ROUTES /POLICY:** A motion was made by Mr. Danzinger seconded by Mr. Weiss to recommend to the Buffalo County Board of Supervisors to have the County Board Chair appoint an Ad Hoc Committee consisting of some members of the Highway Committee, Towns, Law Enforcement, Rider Club member, and possibly from another county to prepare a draft ordinance for consideration by the Highway Committee and full County Board. Motion Carried.

**CONSIDERATION/ACTION – RESOLUTION ON COUNTY AID FOR TOWN BRIDGES & CULVERTS:** A motion was made by Mr. Weiss seconded by Mr. Ruff to approve the resolution for County Aid for Town Bridges and Culverts – Section 82.08 of the Statues. Motion Carried. The committee would like to see a policy that a hydrology study is completed prior to approval of any joint culvert projects in 2021.

**COMMISSIONER’S REPORT:** Mr. DeWitt reported that Mr. Jim Palkowski is bidding out the fuel contracts for next year and will have bids for a future meeting. He stated that he would like to schedule a meeting to drive the County roads as a group and visit all the facilities. Mr. DeWitt asked the members if the vouchers they received electronically were sufficient or if they wanted additional details mailed to them. The Committee requested to have the detailed vouchers sent in the mail as the other report did not provide enough information. Mr. DeWitt reported that the shoulders on Road E and State Road 88 should be completed this Wednesday or Thursday.

**COMMITTEE MEMBER’S REPORT:** Chair Mr. Hillert stated that the committee would need to make sure that the bond funding is spent, and maintenance projects are completed in 2021 either by completing the work in-house or contracting. He indicated that if we are going to bid out work that this should be done by no later than February.

Mr. Ruff informed Mr. DeWitt that the beaver dams on County Road I are still a problem.

**Next Meeting Date and Time:** The next meeting will be December 8, 2020 at 8:00 a.m.

**Adjournment:** A motion was made by Mr. Hillert seconded by Mr. Weiss to adjourn the meeting. Motion Carried.

**Review/Discussion/Action – The Committee May Return to Open Session:** A motion was made by Mr. Don Hillert seconded by Mr. Sendelbach to return to open session. Roll Call vote: Mr. Sendelbach – yes, Mr. Weiss – yes, Mr. Ruff – yes, Mr. Hillert – yes, and Mr. Danzinger – yes. Motion Carried.

### **Review/Discussion/Action – Expectations for Highway Commissioner:**

Mr. Sendelbach made a motion seconded by Mr. Weiss to add the following expectations to the existing Department Manager Expectations as follows:

- Oversees cross training of office staff
- Oversees cross training of Patrol Superintendent with Highway Commissioner duties and responsibilities (handle duties and responsibilities in the absence of the Highway Commissioner)
- Oversees cross training of positions that require specialized training, such as, large equipment operators

  - Status of Staff Off from Work Due to Related Work Injuries
  - Vacancies
- Incident Report (including but not limited to incidents involving staff and equipment)

**GOALS WITHIN THE FIRST 90 DAYS:**

1. Re-evaluate operation for efficiencies and report back to the Highway Committee with recommended changes or changes made.
2. Research contracting fuel and make recommendation to Highway Committee.

Roll Call vote: Mr. Weiss – yes, Mr. Ruff – yes, Mr. Hillert – yes, Mr. Danzinger – yes and Mr. Sendelbach – yes. Motion Carried.

**Public Comment Unrelated to Agenda:** Ms. Hansen informed the Committee that she had receive a request for land access where a guardrail would need to be removed on a county road and inquired as to the process. She indicated that the individual was told that the interim Highway Commissioner did not feel that he had the authority to address this matter. It was the consensus of the Committee to have this individual present his request to them at their December meeting and that pictures would be helpful.

Committee member Mr. Ruff indicated that he had concerns about the ditch on the South road along the Alma Highway Shop needing some dredging due to fallen willow trees. He also indicated that there is an area on the Alma Highway Shop that appears to look like a dump with mattresses and plastic that should be cleaned up.

Committee member Mr. Weiss stated that Mr. James Palkowski is looking into contracting fuel.

Chair Mr. Hillert adjourned the meeting at 8:50 a.m.

## **AN ORDINANCE DESIGNATING ALL-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL- TERRAIN VEHICLES**

WHEREAS, the Buffalo County Board of Supervisors adopts this ordinance pursuant to the authority of Sections 23.33(8)(b), 23.33(11) and 59.02, Wis. Stats. as amended. In addition, the provision of Sec. 23.33, Wis. Stats. and the provisions of Wisconsin Administrative Code NR 64 regulating ATV operations; and,

WHEREAS, Section 23.33(11) (am), Wis. Stats. allows counties with respect to highways under their jurisdiction to designate highways as all-terrain vehicle routes; and,

WHEREAS, in order to assure safe use of all-terrain vehicles and utility terrain vehicles, the Buffalo County Board of Supervisors adopts the following:

**Section I - Purpose or Intent:** Buffalo County adopts the following ATV/UTV routes for the operation of ATV/UTV's upon the roadways listed in Section IV. Following consideration of the recreational value of ATV/UTV use in Buffalo County and the potential impacts to the public's health, safety, and welfare, this Ordinance is created and adopted. A copy of a map showing the location of the ATV/UTV routes shall be kept on file at the Buffalo County Highway Department and the Buffalo County Sheriff's Department.

### **Section II – Definitions:**

The following definitions apply throughout this chapter:

1. All-Terrain Vehicle ("ATV") has the meaning specified within Sec. 340.01(2)(g), Wis. Stats.
2. ATV/UTV Route shall mean a highway designated for use by all-terrain and utility-terrain vehicle operators by the governmental entity having jurisdiction.
3. Utility-Terrain Vehicle ("UTV") has the meaning specified in Sec. 23.33(1), (ng), Wis. Stats.

**Section III – Routes:** The following roads are designated as ATV/UTV routes:

1. No designated ATV/UTV route may be used until approved as open for use by the Buffalo County Highway Committee and properly signed.
2. The Buffalo County Board or the Buffalo County Highway Committee may suspend any route at any time for any reason.

3. If it is determined by the Buffalo County Highway Department that a road must be closed due to emergency or other safety issues, the ATV/UTV route will be suspended until such time as the road is reopened.
4. The Buffalo County Highway Department shall maintain a list of approved all-terrain vehicle routes open for use on County Trunk Highways.
5. The Buffalo County Clerk shall ensure a copy of the approved open for use route is sent to the Buffalo County Sheriff's Office, state traffic patrol and to any other law enforcement agency having jurisdiction over any portion of the route adopted, as well as the Department of Natural Resources in Madison, Wisconsin.

**Section IV – Conditions:** The operation of ATV's and UTV's on any portion of a Buffalo County Trunk Highway designated as an ATV/UTV route shall be subject to the following:

1. Operation shall be subject to all provisions of Sec. 23.33, Wis. Stats., which is adopted as part of this ordinance by reference to Sec. 23.33(11), Wis. Stats.
2. All ATV/UTV operations shall observe a speed limit of not more than 35 MPH or the posted roadway speed limit, whichever is lower.
3. All ATV/UTV operators shall ride single file on the far-right hand side of the paved portion/lane of traffic of the roadway. Operation on the gravel shoulders, grassy in-slope, ditches, or other highway right-of-way area is prohibited. Left turns may be made from any part of the roadway which is safe given prevailing conditions.
4. All ATV/UTV operators shall maintain liability insurance for their ATV/UTV in the amount established by the State of Wisconsin for motor vehicle operation and by utilizing any ATV/UTV, agrees to fully indemnify and hold harmless Buffalo County for all liability arising from use or non-use of ATV and/or UTVs on Buffalo County Trunk Highways.
5. All ATV/UTV operating on county roads must be equipped with a functioning headlamp and tail lamp illuminated, while operating on a County Highway.
6. All ATV/UTV operators shall observe a nighttime curfew and shall not operate their ATV/UTV for the period of one (1) hour prior to sunrise and no later than 10:00 p.m.
7. ATV/UTV routes will be open for use from April 1 through December 1.
8. On all roads shared with another jurisdiction the most restrictive ordinance shall apply.
9. All ATV/UTV operators ages 16 years or older must have a valid drivers license. All ATV safety certified operators age 12-15 must also be accompanied by a parent, guardian or adult designated by the parent or guardian with continuous verbal direction and physical control. Any such parent, guardian or adult shall hold a valid drivers license. Anyone under age 12 cannot operate on any roadways.
10. All operators under the age of 18 must wear protective headgear as required by Sec. 23.33, Wis. Stats.
11. All occupants riding in, or operating a UTV, shall be required to wear a seatbelt when travelling on any trail or route within Buffalo County.
12. It shall be unlawful for any person to possess any bottle or receptacle containing alcohol beverages if the bottle or receptacle has been opened, the seal has been broken, or the contents of the receptacle has been partially removed, while operating or as a passenger on an ATV or UTV on any road or road route in Buffalo County.

13. ATV/UTV operators who are born after January 1, 1988 and operating on a highway are required to have an ATV Safety Certificate provided by the Department of Natural Resources.

**Section V – Signs:** The Buffalo County Highway Department, as the maintaining authority for highways designated as ATV/UTV routes, shall have oversight of the installation of signage in compliance with s. NR 64, Wisconsin Administrative Code. The quantity and location of signs shall be reviewed and approved by the Buffalo County Highway Department.

1. No person may intentionally remove, damage, deface, move, or obstruct any uniform ATV/UTV route or trail sign or standard or intentionally interfere with the effective operation of any uniform ATV/UTV route or trail sign.
2. All costs for signage, installation, maintenance and removal shall be borne by the Buffalo County Trail Riders. The Buffalo County Trail Riders may assist the Buffalo County Highway Department in the installation of signs under the direction of department staff to help defer costs of installation.
3. Signs may be mounted on any existing Buffalo County signpost or utility post/pole. Posts shall be suitably sized for mounting the necessary number of signs at the location.
4. No person shall operate an ATV/UTV contrary to any authorized and official posted sign.

**Section VI – Enforcement:** This ordinance shall be enforced by any law enforcement officer as applicable and authorized to enforce the laws of the State of Wisconsin, as set forth in Wisconsin Statutes Sec. 23.33(12).

**Section VII – Penalties:** The State of Wisconsin All-Terrain Vehicles penalties as found in Sec. 23.33(13)(1), Wis. Stats. and/or any resolutions are adopted by reference.

**Section VIII – Severability:** The provision of this ordinance shall be deemed severable and it is expressly declared that the County would have passed the other provisions of this ordinance irrespective of whether one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons circumstances shall not be deemed affected.

**Section IX – Saving Clause:** This Ordinance in no way be deemed to supplant or otherwise invalidate any provisions of state statute relating to the subject matter hereof. Any person entrusted with the enforcement of this Ordinance may, in the exercise of his or her discretion, proceed under applicable state statutes.

**Section X – Effective Date:** This ordinance becomes effective upon passage and publication.
