Barry Drazkowski called the joint meeting to order at 9:03 a.m. in the third floor County Board meeting room, Buffalo County Courthouse, Alma, Wisconsin.

**Public Comments Regarding Agenda Items:** Ms. Sonya J. Hansen indicated that Mr. John Ebert had responded that “Joe’s resignation was unexpected in such immediate fashion, but this leaves a few opportunities to change culture and build new relationships”.

**Review/Discussion ~ County Surveyor:**

Ms. Sonya J. Hansen informed the committee members that she had spoken with Mr. Ron Jasperson who stated that Mr. Joe Nelsen had appointed him as the Deputy Surveyor and that he was interested in becoming the County Surveyor. He had informed her that the existing records held by Mr. Joe Nelsen were in their office. No action was taken by either committee. Ms. Hansen is to contact Mr. Ron Jasperson to verify his hourly rate and draft a resolution for the committees to consider at their next meeting. The committees agreed that a job description should be developed with expectations that meet the needs of the County.

The committees agreed that a sub-committee should be formed to develop a plan to move the remonumentation project forward with options for the full County Board of Supervisors to consider. Hansen will contact the County Board Supervisor representing the towns of Canton and Maxville to see if he is willing to serve as a member.
